The CanTRA Silent Bid Stallion Auction will be held during the last 2 complete weeks of January every year. CanTRA will start the bidding at half the regular stud fee, with increments of \$50.

Upon receipt of the final bid money for your stallion, you will be sent a tax receipt for the amount of your regular stud fee*. Your stallion will be listed on the CanTRA website & will be listed in various equestrian magazines such as Canadian Horse Journal as acknowledgement of your generous support for CanTRA. If you have a 'flyer' for your stallion, send a minimum of two copies to CanTRA for display and promotional purposes, (i.e. The Royal Winter Fair).

*In order to qualify for a tax receipt we need to be able to prove the market value of your regular stud fee. This must be in writing from an impartial third party who is knowledgeable in the field but doesn't necessarily need to be a veterinarian or other certified professional. Alternatively, if your stallion is listed on any approved equine associations' website or other listings, this can be used to prove market value.
