

The important goal for the certification committee for 2021 was the implementation of a virtual certification program for the CanTRA Basic Instructor and Basic Instructor 2, due to COVID restrictions.

A number of candidates who had completed their technical evaluation prior to 2019 were waiting for an exam date to complete their Basic Level.

In June 2021, we held our first virtual exams and have completed all the outstanding exams over the latter months of 2021. By this time, COVID 19 restrictions had started to be lifted and we were able to conduct virtual Zoom or video sessions at various centres that were holding classes as allowed by provincial/regional guidelines. Each event included one or two candidates with two examiners reviewing videos and all applicable paperwork that accompanies an exam. We were able to hold events at a candidate's home centre. Once we return to in-person events, we will revert to holding technical evaluations and exams at our examination centre.

An ad hoc committee from the Certification committee members used our time over the last year to re-write the CanTRA Instructor Manual. This was an almost complete re-write as the first edition of the Manual was published

in 1986. At the present time, the manuscript is in the hands of an Editor for formatting and a Book Designer. We eagerly look forward to offering this to our members in either hard copy or digitally in the next few months.

It seems there is a severe shortage of instructors and mentors following two years of the pandemic. This next year promises to be a busy time for

certification and for centres training candidates and holding exams to fill the gaps.

Hippotherapy Canada Committee

Annual Report for CanTRA March 2022

Hippotherapy Canada met four times over 2021. Meetings were via Zoom. The group now has 20 participants registered across Canada.

Our main focus is to help therapists across Canada to connect and provide education and resources.

Currently we are completing a survey to better meet the needs of therapists across Canada in terms of what support and resources we can offer in the hopes of boosting meeting attendance and participation.

Research:

This year Janessa Whitfield, PT, and Pippa Hodge PT worked on a pilot study examining the efficacy of Physiotherapy utilizing equine movement in older adults. Jacqui Ryan, MD, helped with this study and getting a poster produced which all three presented at the American Hippotherapy Association Conference held in Denver, Colorado in March 2022. The data was processed by Longlong Huang, a statistician at the University of the Fraser Valley.

Nine individuals between the ages of 61 and 79 years were treated using equine movement once weekly for 12 weeks. Each person had 30 minutes on the horse and exercises focused on balance, postural correction, flexibility, coordination, strengthening and dual tasking exercises.

The Boomer (Balance Outcome Measure for Elder Rehabilitation) was used to measure change and this did show an improvement in balance in the subjects.

We are continuing to study the effectiveness of Hippotherapy treatment on the older population to see if it improves functional mobility and balance outcomes.

Equine Facilitated Wellness

During 2021 the CanTRA Board, the Equine Facilitated Wellness Committee, the Certification Committee and the Accreditation Committee all came together to develop a new program for CanTRA Equine Facilitated Wellness. With this collaborative effort, three new documents have been developed and made available to CanTRA members.

The first of these documents is a new CanTRA Equine Facilitated Wellness Manual. This maps out the three different types of CanTRA Equine Facilitated Wellness qualifications:

- Mental Health Professional
- Education Professional or Practitioner
- Equine Specialist or Senior Equine Specialist

The new manual also describes the process by which a person can make an application through a portfolio method. This will take into consideration each person's individual and unique experience.

The second of the documents is the Equine Facilitated Wellness Horse Handler document. The EFW Horse Handler will function as a support for the Equine Specialist. This document describes the process of qualifying as

an EFW Horse Handler.

The third document, which describes the requirements for becoming a CanTRA centre that is accredited to provide equine facilitated wellness services, was circulated to all CanTRA member centres.

The new program will be unfolding throughout 2022.

The existing Equine Facilitated Wellness Committee was dissolved at the end of 2021 and will be restructured at some point in the future.
